- A. Principal's Report provided by Mr. Bowman included updates on observation status, a review of recent events including family night, parent teacher conferences / grandparents day, which was in coordination with the book fair, and NHS Ceremony; This year's Christmas concert is December 18 at 6pm.
- **B.** Business Manager's Report reviewed by Mr Boensch included State Aid revenue review and breakdown of known line items; a budget amendment will be ready next month. An MDE Fiscal Monitoring review for the Consolidated Application took place last week; we had no findings.
- C. Superintendent's Report detailed by Mr. Yorke included updates on the ICAN project, which is up and running with preschool; new staff are in place and parent/family meeting participation is increasing; athletics have transitioned from fall to winter; a recap of fall sports and upcoming events/practices was given. He thanked Mr. Boensch for his diligence in keeping us in program compliance, as well as Mrs. Scholtz for supporting those efforts in the business office; he thanked office staff and all involved for their efforts with recent events including the Veterans Day celebration. Mr. Yorke suggested getting a committee together for new principal selection. Mr. Spaw asked that thanks be relayed to Mrs. Look for coordination of the Veteran's Day Celebration; it was very nice.
- **D.** MiCIP Team Report Mrs. Blomquist and Mrs. Nieman reviewed assessments and progress monitoring and stated that they are seeing large growth across the elementary; a review of Michelle Goaley's visit was also given; both Mrs. Nieman and Mrs. Blomquist are attending the MICIP conference this Thursday; they highlighted key session content.

D. Hire Secondary Social Studies Teacher
